

Addendum dated March 26, 2015 to the Combined Scheme Information Document of the schemes of L&T Mutual Fund

The following changes shall be carried out in the Combined Scheme Information Document (“Combined SID”) of the schemes of L&T Mutual Fund (“the Fund”) with effect from March 27, 2015. This change will be applicable on a prospective basis.
