

Addendum dated April 1, 2015 to the Scheme Information Document of L&T FMP – Series X – Plan Q (390 days) ("the Scheme")

In light of the current business and operating environment and in accordance with the provisions pertaining to roll-over as per Regulation 33(4) of the Securities and Exchange Board of India (Mutual Funds) Regulations, 1996 ("SEBI Regulations"), it is proposed to extend the maturity of the Scheme for a further period of 1121 days from and including the date of extension i.e. April 8, 2015 and therefore the Scheme will now mature on May 2, 2018. The proposed extension will be subject to compliance with requirements under SEBI Regulations.

As a result of the aforesaid extension, the following changes will be carried out in the Scheme Information Document with effect from April 8, 2015:

A. Name:

As a result of the aforesaid roll-over, the new name of the Scheme will be L&T FMP – Series X – Plan Q (1511 days).

Accordingly, with effect from April 8, 2015 all references in the Scheme Information Document to the name of the Scheme will be replaced with L&T FMP – Series X – Plan Q (1511 days).

B. Tenure:

The tenure of the Scheme shall be 1511 days (1121 days from and including the date of extension i.e. April 8, 2015)
