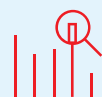
Why HSBC Flexi Cap Fund?

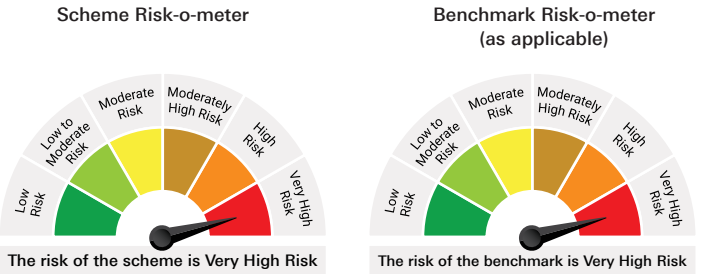
