## Investment Objective

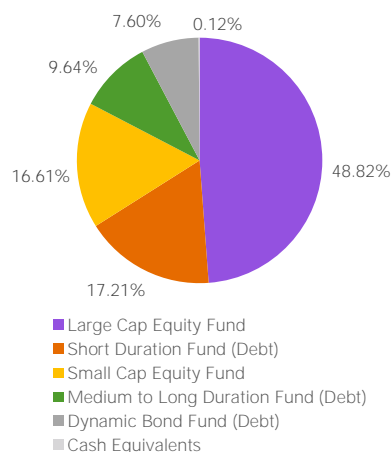

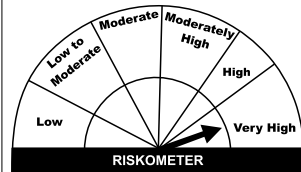
