1. HSBC Asia Pacific (Ex Japan) Dividend Yield Fund
2. HSBC Brazil Fund
3. HSBC Global Emerging Markets Fund*

Hereafter referred to as ‘**Designated Schemes**’ of the Fund.

***Note** - HSBC Global Equity Climate Change Fund of Fund was merged into the HSBC Global Emerging Markets Fund with effect from March 25, 2026.

The above-mentioned subscriptions in the Designated Schemes will be allowed only upto the headroom available without breaching the overseas investments limits as of February 1, 2022 at the Fund level. The AMC reserves the right to suspend the processing of subscriptions in the Designated Schemes temporarily if the overseas investments are close to the limits as of February 1, 2022 at Fund level.

This notice cum addendum forms an integral part of the SID(s) / KIM(s) of the Designated Schemes, as amended from time to time.

All the other terms and conditions of the SID and KIM of the schemes of the Fund will remain unchanged.
