Investment Objective

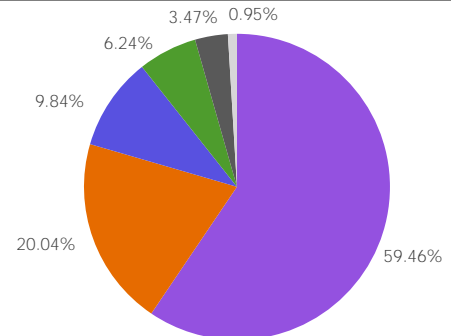
