HSBC Global Investment Fund Global Emerging Markets Fund (HGMF) (Underlying fund strategy) Monthly

At sector level, stock selection was positive for the month. Positive performance came from Consumer Discretionary and Industrials, though this was offset by negative stock selection in Financials and Consumer Staples.

At country level, stock selection was positive for the month. Positive performance came from Mainland China and India, though this was offset by negative stock selection in Brazil and Taiwan.

Mainland China Consumer Discretionary security, **ALIBABA GROUP HOLDING LTD** with total effect 0.92% is the top contributor. Additionally, Mainland China Consumer Discretionary security, **BYD CO LTD-H** was the second largest contributor with total effect 0.90%. Mainland China Communication Services security, **TENCENT HOLDINGS LTD** also contributed with total effect 0.34%.

On the other side, detractors included Indonesian Financials security BANK RAKYAT INDONESIA PERSER with total effect -0.38%, Brazilian Financials holding, **NU HOLDINGS LTD/CAYMAN ISL-A** with total effect -0.37%, and Indian Consumer Staples holding, **HINDUSTAN UNILEVER LTD** with total effect -0.22%.

During this period, no positions were opened. No positions were closed.

Sector and Country allocation effects are residual to stock selection. At a country level, effects were positive, given an overweight exposure to Mainland China. At sector level, effects were positive, given an overweight exposure to Communication Services.

HSBC Global Emerging Markets Fund (Fund of Fund)

The primary investment objective of the Scheme is to provide long term capital appreciation by investing predominantly in units/shares of HSBC Global Investment Funds - Global Emerging Markets Equity Fund. 
