Market update

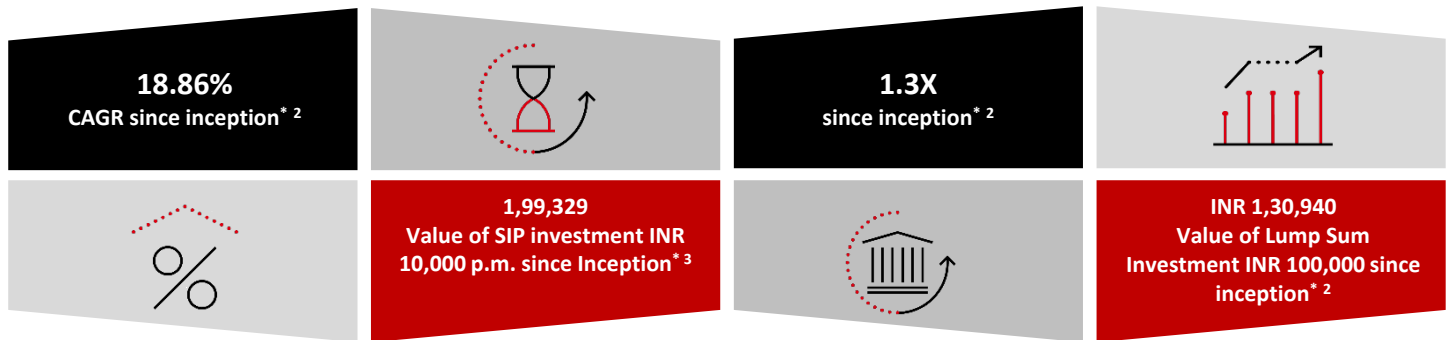
