Investment commentary – HSBC Global Investment Fund Brazil (Underlying Fund)

At sector level, stock selection was positive for the month. Positive performance came from Utilities and Industrials, though this was offset by negative stock selection in Financials and Materials.

Industrials security, **LOCALIZA RENT A CAR** with total effect 0.17% is the top contributor. Additionally, Utilities security, **EQUATORIAL ENERGIA SA - ORD** was the second largest contributor with total effect 0.12%. Financials security, **BANCO BTG PACTUAL SA-UNIT** also contributed with total effect 0.09%.

On the other side, detractors included Financials security **BB SEGURIDADE PARTICIPACOES** with total effect -0.18%, Financials holding, **BANCO BTG PACTUAL SA-UNIT** with total effect -0.15%, and Industrials holding, **GPS PARTICIPACOES E EMPREEND** with total effect -0.12%.

During this period, positions were initiated in **SMARTFIT ESCOLA DE GINASTICA**.

No positions were closed.

Sector allocation effects are residual to stock selection. At sector level, effects were negative, given an underweight exposure to Consumer Discretionary.

Investment quarterly commentary – HSBC Global Investment Fund Brazil (Underlying Fund)

At sector level, stock selection was negative for the quarter. Positive performance came from Consumer Discretionary and Health Care, though this was offset by negative stock selection in Consumer Staples and Financials.

Industrials security, **LOCALIZA RENT A CAR** with total effect 0.24% is the top contributor. Additionally, Financials security, **XP INC - CLASS A** was the second largest contributor with total effect 0.23%. Industrials security, **EMBRAER SA-SPON ADR** also contributed with total effect 0.20%.

On the other side, detractors included Industrials security **EMBRAER SA** with total effect -0.43%, Consumer Staples holding, **ATACADAO SA** with total effect -0.33%, and Financials holding, **BANCO BTG PACTUAL SA-UNIT** with total effect -0.29%.

During this period, positions were initiated in **iShares MSCI Brazil ETF (DE)**, **EMBRAER SA-SPON ADR**, **INTER & CO INC - CL A**, and **SMARTFIT ESCOLA DE GINASTICA**. Positions were closed in **LOCALIZA RENT A CAR**, **STONECO LTD-A**, and **PAGSEGURO DIGITAL LTD-CL A**.

Sector allocation effects are residual to stock selection. At sector level, effects were negative, given an underweight exposure to Consumer Discretionary.
