#### Investment Objective

The primary investment objective of the Scheme is to provide long term capital appreciation by investing predominantly in units/shares of HSBC Global Investment Funds (HGIF) Brazil Equity Fund. The Scheme may, at the discretion of the Investment Manager, also invest in the units of other similar overseas mutual fund schemes, which may constitute a significant part of its corpus. The Scheme may also invest a certain proportion of its corpus in money market instruments and/or units of liquid mutual fund schemes, in order to meet liquidity requirements from time to time. #### Investment commentary – HSBC Global Investment Fund Brazil (Underlying Fund)

At sector level, stock selection was negative for the month. Positive performance came from Consumer Discretionary and Utilities, though this was offset by negative stock selection in Industrials and Energy.

Energy security, **PETROBRAS - PETROLEO BRAS** with total effect 0.20% is the top contributor. Additionally, Consumer Discretionary security, **MERCADOLIBRE INC** was the second largest contributor with total effect 0.20%. Consumer Discretionary security, **SMARTFIT - ORDINARY** also contributed with total effect 0.18%.

On the other side, detractors included Industrials security **LOCALIZA RENT A CAR** with total effect -0.45%, Energy holding, **PRIO SA** with total effect -0.24%, and Utilities holding, **EQUATORIAL ENERGIA SA - ORD** with total effect -0.21%.

During this period, positions were initiated in **EQUATORIAL ENERGIA SA - ORD**. No positions were closed.

Sector allocation effects are residual to stock selection. At sector level, effects were negative, given an underweight exposure to Financials.
