At sector level, stock selection was negative for the month. Positive performance came from Utilities and Financials, though this was offset by negative stock selection in Information Technology and Communication Services.

At country level, stock selection was negative for the month. Positive performance came from Indonesia and Singapore, though this was offset by negative stock selection in Taiwan and Hong Kong (SAR).

mainland China Communication Services security, BAIDU INC-CLASS A with total effect 0.27% is the top contributor. Additionally, mainland China Consumer Staples security, TINGYI (CAYMAN ISLN) HLDG CO was the second largest contributor with total effect 0.18%. Indian Utilities security, POWER GRID CORP OF INDIA LTD also contributed with total effect 0.14%.

On the other side, detractors included Hong Kong (SAR) Consumer Staples security LOCCITANE INTERNATIONAL SA with total effect -0.35%, Korean Communication Services holding, SK TELECOM with total effect -0.29%, and mainland China Real Estate holding, SHIMAO GROUP HOLDINGS LTD with total effect -0.21%.

During this period, no positions were opened.

Positions were closed in CHINA RESOURCES CEMENT, TENCENT HOLDINGS LTD, and INDUS TOWERS LTD.

Sector and Country allocation effects are residual to stock selection. At a country level, effects were negative, given an underweight exposure to Korea. At sector level, effects were negative, given an underweight exposure to Consumer Discretionary.

At sector level, stock selection was negative for the quarter. Positive performance came from Communication Services and Utilities, though this was offset by negative stock selection in Financials and Materials.

At country level, stock selection was positive for the quarter. Positive performance came from mainland China and Singapore, though this was offset by negative stock selection in India and Australia.

mainland China Communication Services security, TENCENT HOLDINGS LTD with total effect 0.50% is the top contributor. Additionally, Australian Energy security, SANTOS LTD was the second largest contributor with total effect 0.29%. Indian Utilities security, POWER GRID CORP OF INDIA LTD also contributed with total effect 0.28%.

On the other side, detractors included Hong Kong (SAR) Financials security HONG KONG EXCHANGES & CLEAR with total effect -0.37%, Australian Materials holding, SOUTH32 LTD with total effect -0.35%, and mainland China Communication Services holding, BAIDU INC-CLASS A with total effect -0.26%.

During this period, positions were initiated in KINSUS INTERCONNECT TECH, UNITED MICROELECTRONICS CORP, and UNIMICRON TECHNOLOGY CORP.

Positions were closed in INDUS TOWERS LTD, HCL TECHNOLOGIES LTD, UNITED TRACTORS TBK PT, CHINA RESOURCES CEMENT, and COMMONWEALTH BANK OF AUSTRAL.

Sector and Country allocation effects are residual to stock selection. At a country level, effects were positive, given an overweight exposure to mainland China. At sector level, effects were positive, given an overweight exposure to Consumer Discretionary.






