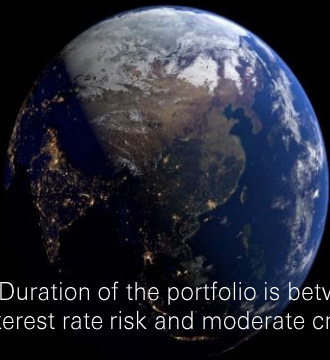

- The fund typically has a relatively higher portfolio average maturity as compared to liquid/cash fund

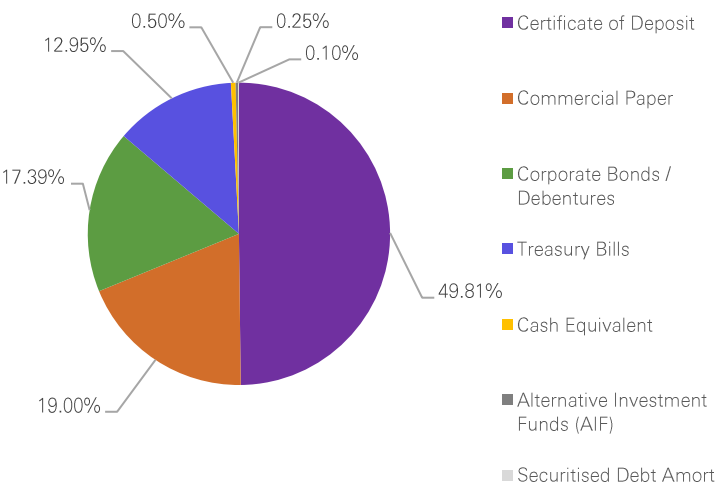

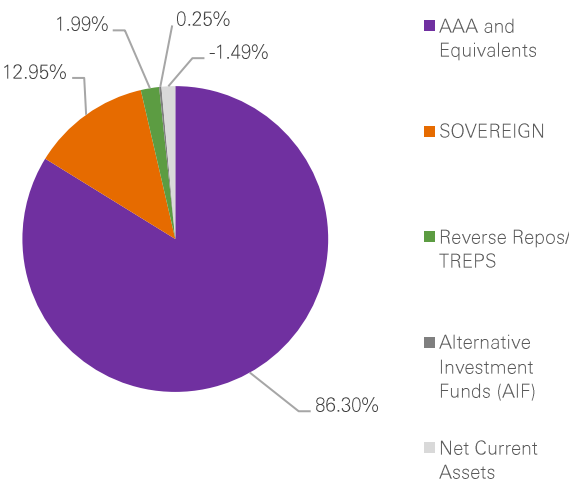

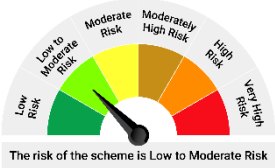
