Portfolio Manager's commentary:

India is a unique country where both vibrancy of music concerts and spiritual immersion of the Maha Kumbh draw big crowd and drives economy! Though long-term India structural story remains intact, short-term pain is visible in stock markets. Indian Stock markets continued its losing streak with its fourth consecutive monthly loss, the longest streak since September 2001 driven by persistent FII selling, uncertainty around tariffs under Trump 2.0, a depreciating rupee and domestic growth concerns. FIIs sold \$8.4bn of equities in January month, recording its second-highest monthly outflow after Oct-24. DIIs remained net buyers for the 18th consecutive month, with strong inflows of \$10bn. Trade war initiated by the US levying tariff on Mexico, Canada & China and further threat of imposing tariff on EU region is likely to add further uncertainty in global economy. Valuation correction in certain pockets of the markets especially theme-based stocks may continue as these stocks have long been trading at high valuations factoring very strong earnings growth.

The recently announced union budget has pivoted towards consumption stimulus. In a strategic move to energize the economy, the budget has proposed tax reforms aimed at increasing personal disposable income and stimulate consumption. In the backdrop of global landscape marred by the threat of "retreating globalization" and domestic economy grappling with inflation and subdued growth, the budget addresses pressing concerns of the nation, putting spotlight on the middle-class, the backbone of India's growth & development. The budget has deftly managed both growth & fiscal discipline by boosting consumption engine while sticking to fiscal prudence. It put more money in the hands of people by realigning tax slabs (Rs.1th higher disposable income), increasing allocation for rural schemes and enhancing credit limit for KCC (Kisan Credit Card) farmers. Consumption being one of the major themes of our HINP strategy, many quality stocks with focus on discretionary consumption are big beneficiary of this announcement in the long run.

3QFY25 corporate earnings season is in full swing. Around 133 companies in BSE200 (73% of market cap) have reported their Q3 results so far. Net sales growth held up at 5.5% YoY vs 4.6% in Q3, while EBIT growth improved to 9% YoY vs a decline of 4% in Q2. Ex-Energy/ Metals, the trend is better with sales growth at 10% and EBIT growth at 13%. Overall, positive surprises (vs expectations) were few, with misses concentrated in Autos and Energy.

We have undertaken partial profit booking in stocks such as Persistent Systems, Indian Hotels & Zomato Ltd during the month. The current cash level in the portfolio is high and we will judiciously deploy it after analysing 3Q FY25 results. As we navigate this promising yet complex environment, the choices we make in the portfolio based on disciplined investment approach with focus on cash flows, sustainable earnings growth trajectory and management quality will determine the risk adjusted returns in the medium to long term.
