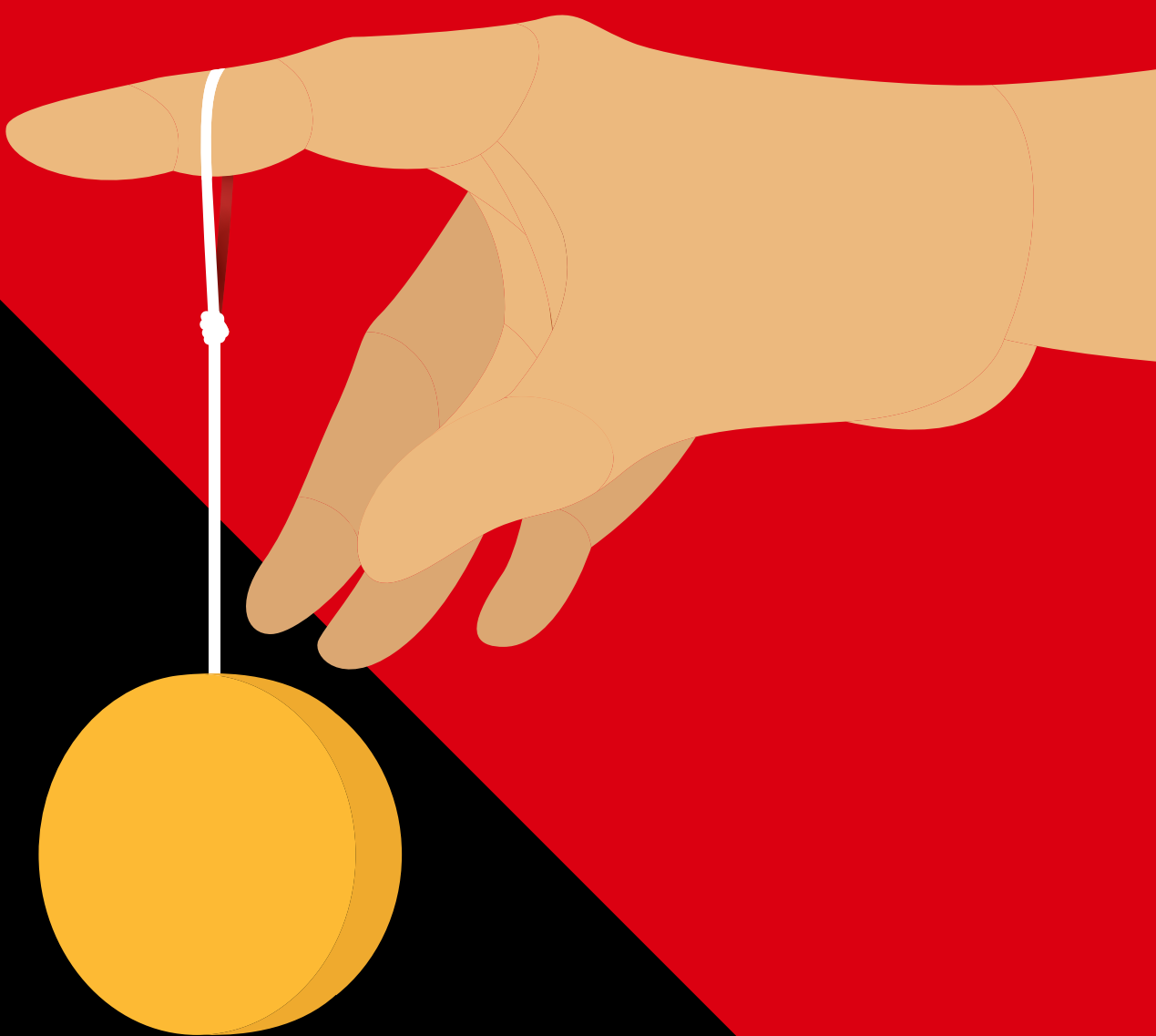


Diversify.

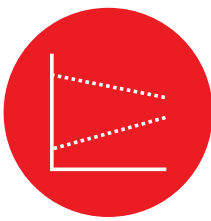

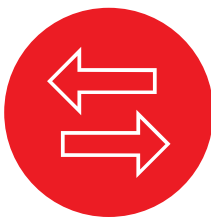
Spread your investments across various asset classes.
